- 1) The Registration Roster is open to all guild members on a first come, first serve basis with this Information Sheet and the **\$50** deposit to hold the spot. All monies are due one month prior to the event. **Waiting List:** No deposit is required from waiting list participants, but the Information Sheet is required, and the deposit is required in order to be moved to the Roster. **Refunds:** slots may be filled from a priority waiting list with all fees refunded. The new (replacement) participant encumbers all required fees. In the event there is no waiting list, refunds will **ONLY** be granted when the Guild is not encumbered by contractual responsibilities as the event is self-supporting. - 2) Any person (s) creating a verbal or physical situation that leads to the disruption of or the feeling of being unsafe at a retreat will be immediately removed from the premises of the retreat.  
 a) No monetary fees for the retreat will be returned.  
 b) The person (s) in charge of such retreat has the responsibility to enforce the above and gain assistance from legal enforcement if necessary, to maintain the safe and productive environment.
