1) Registration is open to all guild members on a first come, first serve basis with a deposit to hold the spot. All monies are due one month prior to the event (November meeting---No monies will be taken at the Christmas meeting.) No deposit is required from waiting list participants. Refunds: slots may be filled from a priority waiting list with all fees refunded. The new (replacement) participant encumbers all required fees.
